Privacy information supplier portal

Preamble

This privacy policy informs in accordance with the data protection regulations on the collection of data by the data subject, in particular with regard to Art. 13 GDPR in conjunction with Art. 6 GDPR and related processing of personal data when using the supplier portal of the Woco Group.

3 Purpose, legal basis and legitimate interest

The processing of personal data takes place in order to establish supplier relationships of the Woco Group and serves to select suitable suppliers for the Woco Group as well as to initiate agreements in connection with tenders and service requests.

The information requested in the context of the registration in the portal is thus either based on Art. 6 I lit. b GDPR "fulfillment of a contract" for the precontractual measures required, or constitute voluntary information provided by the supplier based on Art. 6 I lit. a GDPR "Consent" to be processed. The voluntary disclosure of information corresponds to the consent.

When visiting the supplier portal, data on access and user activities (so-called server log files) are also collected. This technical access information based on Art. 6 para. 1 lit. f GDPR (legitimate interest) serve exclusively to improve the usability of our offer and, if necessary, to identify technical problems at an early stage.

4 Recipients or categories of recipients

The supplier portal serves the group-wide selection of suppliers and service providers. Therefore, the supplier data is provided to the companies of the Woco Group.

As part of the processing, this data as well as the server log data are transmitted to the technical operator of the portal, SynerTrade SES AG, based in Munich, Germany.

A transfer to third countries does not take place.

5 Storage time

The details of the registered suppliers are permanently required for supplier management and remain stored. Deletion of data from rejected suppliers is only at the express request of the supplier.

6 Rights of persons affected

As the person concerned, you are generally entitled to **information** about which personal data has been stored about you. If your request does not conflict with a legal obligation to store data, you are entitled to **correct** incorrect data and to **delete** or **restrict** the processing of personal data. If processing is based on consent (pursuant to Article 6 (1) (a) GDPR or Article 9 (2) (a) GDPR), such consent may be **withdrawn** at any time without the legality of the consent granted by the date of consent. Withdrawal occurred processing is touched. In addition, you have a right to **data portability**.
